Twin fetuses have been of particular interest to investigators seeking clues on the relative roles of nature versus nurture in human fetal growth. Dr. L.S. Deshmukh has reviewed Neonatal outcome in twin pregnancy.

Every 5 minutes, a baby is born with birth defect. A dream of motherhood is shattered and psychological and emotional trauma is inflicted when obstetrian discloses to the mother, that her child is malformed. Dr. Varsha Deshmukh has evaluated fetal infections as an etiological factor for congenital malformations.

In Neonatal Progeroid Syndrome, features of human aging are apparent at birth. DNA damage may arise from Reactive Oxygen Species, chemical reactions, radiations, depurination, deamination. More than 30 cases have been reported in literature. Dr. Trupti Gujarathi has reported this rarest syndrome.
